Tom Moran has stated it probably has 8-12 years before it will need another paint job.

Walked the sidewalk in front of CNB and Coldwell Banker. Dan would like to see a straighter line. Mike disagrees. Also walked with Matt Zimmerman to examine poles in the “dark spot” between twp hall and Dairy Mart. 3 or 4 light fixtures are needed. May be able to string electrical access between poles. Walked east side and discussed Charter lines still present and Consumer plan to eliminate 12 poles.
