

APPROVED MINUTES
Tuscarora Township Parks Commission
Regular Meeting June 3, 2025 6:00 p.m.

The meeting was called to order at 1800 Hours.

Board members present were, Beth Henderson, Allen Maves, Gayle Hall, Stacey Cole and Andrew Cole and Patrick McGinnis.

Parks Superintendent Doug Schofield, Parks Superintendent was also present.

Board Members absent: None.

The Parks Commission have a quorum.

There were no Public Comments on Agenda Items.

Andrew Cole asked to have agenda item nine moved to new business item 14. A motion to approve the agenda was made by Gayle Hall and seconded by Allen Maves. All members present voted in favor.

Beth Henderson asked to remove part of the May 6, 2025 minutes that read "A decision was made to wait for a letter from Jeff Lawson authorizing the remaining grant funds at DeVoe Beach and having a new bid for replacing the sand". The section was removed and Gayle Hall made a motion to approve the May 6, 2025 minutes and seconded by Stacey Cole. All members present voted in favor.

A Motion to approve the May 14, 2025 minutes was made by Beth Henderson and was seconded by Gayle Hall. Beth Henderson voted no. All other members present voted in favor.

A motion to pay the bills was made by Beth Henderson and was seconded by Allen Maves. All members present voted in favor.

In the discussion of the Youth Grant for Cooperation Park Gayle Hall made a motion to purchase two new scoreboards at a cost not to exceed \$8,000.00 and the remaining \$2,000.00 would be used for electrical hookup. Allen Maves seconded. All members present voted in favor.

A discussion was held on placing signs at the Green Dock to warn boaters of swimmers in the area. The commission decided that there was not a good place to place the signs.

The commission decided to repost the sale of a truck and trailer on the township's web site.

Beth Henderson made an adjustment to the budget to add liability insurance. A motion to submit the new budget to the township board was made by Stacey Cole and was seconded by Allen Maves. All members present voted in favor.

A discussion was held concerning placing a flag drop off box at DeVoe beach. It was suggested that park by Pat and Garys would be a better location.

A request to place a memorial bench at DeVoe Beach was made. A motion was made by Gayle Hall not to place the bench at DeVoe beach and was seconded by Pat McGinnis. Allen Maves and Stacey Cole voted no. All other members present voted in favor. The commission decided to look into the matter of where a better place might be.

A motion to remove the Porta Johns at the Green Dock was made by Allen Maves and was seconded by Pat McGinnis. Stacey Cole and Gayle Hall voted no. All other members present voted in favor.

Beth Henderson said she would talk to Big Bear concerning their use of the Kayak Launch area.

A discussion was held concerning charging groups for use of parks facilities. No vote was taken.

Beth Henderson made a motion to increase a new hire pay to \$16.50 per hour retro active to the date he started. Gayle Hall seconded the motion. All members present voted in favor.

A discussion was held concerning improving the volleyball area at DeVoe Beach at no cost to the parks.

There were no Public Comments.

There were no Board Comments.

The meeting was adjourned at 2034 hours.
