

**MINUTES OF THE REMOTE AUDIO/VIDEO MEETING  
OF THE TUSCARORA TOWNSHIP BOARD  
January 5, 2021**

Meeting called to order at 7:01 pm by Supervisor Ridley with the Pledge of Allegiance

Audio/Video Remote Virtual

Roll call by Clerk Dolly Rodriguez. Board members present were Mike Ridley Supervisor; Dolly Rodriguez, Clerk; Bobbi Balazovic, Treasurer; Robert Kramer, Trustee; Janet Vance, Trustee. A quorum of the board was present.

Minutes of the December, 2020 meeting were approved. Will dispense as written.

Treasurer's Report

Checking account has \$1,117,886.21 and the \$2,782,402.84 in the general account. Vance made motion to pay bills and Balazovic supported. All in favor.

Police Report

Chief thanked Mark Melvin and the 2 other families for purchasing the new snowmobile for the Police Department. Chief also thanked the Indian River Woman's Club for the purchase of the new body cams for his department. He also thanked the community for its continued support.

DDA Report

We did get our signs and poles in. They are in the storage barn. Still working on the budget. BLPA is trying to raise \$20K to purchase the sculpture. Motion to support the sturgeon sculpture to be placed at M-68 and S Straits Hwy made by Vance and supported by Balazovic. All in favor.

Library Report

Helen Miller, the library Director. The library is now open.

Wahbee Avenue/Hiawatha Road End/Frontenac Rd Discussions

The Tuscarora Township police will continue to check the areas on a routine basis and deal with issues as they come in. Dave Carpenter doesn't recall ever having issues being blocked by vehicles. Road Commission will have the State Police conduct a study.

Fire Contract

Chief Dave Carpenter gave an annual update to the board on the Tuscarora Township Fire Department activities and calls. Presented the board with the 2021 Fire Contract (\$180,638.00). Motion to accept the new fire contract was made by Vance and supported by Balazovic. All in favor.

### Parks Report

Jennifer Andrews thanks Doug Schofield and Cody Whitman for the fantastic job they are doing. Hours have been set for the open skating and hockey at the new ice rink. The new ball field work is completed, the walking hills/trails are being groomed. Winterfest is pending on the Governor/State due to COVID restrictions. Tentative date is February 11-14.
