

**MINUTES OF THE REGULAR MEETING OF THE  
TUSCARORA TOWNSHIP BOARD**

**Tuesday, October 2, 2012**

Meeting called to order at 7:00 pm by Supervisor Ridley.

Members Present: McGinnis, Balazovic, Ridley, Waldron, Fisher

Members Absent: None

32 citizens were in attendance.

The September 4, 2012, regular meeting minutes were approved as previously published; the September 4, 2012, closed meeting minutes were approved as submitted.

Trustee Waldron moved and Treasurer Balazovic seconded to adopt the agenda with the addition of Ken Paquet, CCRC to precede the Police Report. Motion carried.

Ken Paquet, is running for re-election of the CCRC; he has been on the Commission for four years and has been Chairman for the past three years. Paquet reviewed recent accomplishments of the CCRC, what obstacles they are currently facing and asked for support of his re-election.

Police Report: A two month investigation resulted in the arrest of a City of Cheboygan resident for child abusive material and computer crimes. An autistic four year old was found within 50 minutes of his being reported missing by his mother was found within 50 minutes through a joint effort between the TTFD and the TTPD.

Committee reports:

**Marina Park:** No report. **DDA:** Received a \$1.2M loan commitment from Rural Development for the streetscape project. The pathway project will not be going to bid until spring. **Parks Commission:** No report; getting ready for winter. **Beautification:** Working on getting Hide-A-Way Park seeded and graded this fall.

Airport Manager's report: Switching equipment over from summer to winter. The state held another inspection last week on the cement monuments they required to be installed this past summer.

Treasurer's report: The general accounts have \$675,904.85; the tax accounts have \$343,257.79 without interest.

Supervisor Ridley read a Resolution to Authorize Distribution of, and Right to Approve or Reject the Tuscarora Township Master Plan 2012 Update requested by the Planning Commission. Trustee McGinnis moved to adopt the Resolution, Trustee Waldron seconded and a roll call vote was taken: McGinnis, yes; Balazovic, yes; Ridley, yes; Fisher, yes; Waldron, yes. The Cheboygan County Planning Commission will be holding a meeting at the Tuscarora Township Hall on Thursday, October 25, 2012, to review their proposed Master Plan with the Tuscarora Township Planning Commission.

Trustee Waldron moved to approve the Fielder lot split request. Trustee McGinnis seconded and the motion carried with five ayes.

Treasurer Balazovic moved to approve a consulting contract with Clayton McGovern for \$3,750. Clerk Fisher seconded the motion and it carried with five ayes.

Robin and Chris Rohn presented a status update on the request for improvement of three or four road ends on the west side of Burt Lake. After much discussion, Treasurer Balazovic moved to have Supervisor Ridley obtain a windshield estimate for grading and widening the road end at Resort Road. Trustee McGinnis seconded the motion and it carried with five ayes.

Citizen comments: Public comments began at 8:55 p.m. Comments were received from three persons. Comments ended at 8:59 p.m.

Trustee Waldron moved to pay the bills. Trustee McGinnis seconded and it carried unanimously.

Trustee Waldron moved to adjourn at 9:00 p.m.
