

CHECKLIST FOR HOMEOWNERS CONNECTING TO THE TUSCARORA SEWER SYSTEM

Updated 11/3/2025

- Obtain an information packet from Tuscarora Township which contains copies of the required permit applications, lists of contractors, etc. The information is available online at <https://www.tuscaroratwp.com/DocumentCenter/View/1258/Homeowner-Sewer-Hook-Up-Guide> or by calling 231-238-0970 or by emailing admin@tuscaroratwp.com
- Contact Tuscarora Township by calling 231-238-0970 or by emailing admin@tuscaroratwp.com to see if your home is able to connect to the system yet and confirm with them if it will be a gravity connection, gravity with an ejector pump or low-pressure with a grinder pump.
- Select a plumbing contractor to assist you in applying for the required permits and performing the work to connect your house to the sewer lead recently installed at your property line.
- Submit a Township of Tuscarora Application for Sewer Connection. **Your plumbing contractor will likely submit the application for you.** A copy was included in the packet along with an online link to download a copy.
- Submit a Cheboygan County Department of Building Safety Plumbing Permit Application. **Your plumbing contractor will likely submit the application for you.** A copy was included in the packet along with an online link to download a copy.
- If your connection will include either a grinder pump or ejector pump**, also select an **electrical contractor** to assist you in applying for the required permits and performing the electrical work to provide power for the pump.
- If the excavation for your connection will be within 500 feet of a lake or stream** then you will need to submit a Cheboygan County Soil Erosion & Sedimentation Control Permit Application. Your contractor will likely submit the application for you. A copy was included in the packet along with an online link to download a copy. If the area of disturbed earth will be less than 225 square feet then you can submit an Affidavit for Soil Erosion & Sedimentation Control Permit Waiver. A copy of this form was also included in the packet along with an online link to download a copy.
- If your connection will include either a grinder pump or ejector pump**, also submit a Cheboygan County Department of Building Safety Electrical Permit Application. **Your electrical contractor will likely submit the application for you.** A copy was included in the packet along with an online link to download a copy.
